Subject: Clarification on Quarterly submission of shareholding pattern for March 31, 2025.

Dear Sir / Madam,

This has reference to your observation regarding the Shareholding Pattern submitted for the quarter ended March 31, 2025.

1. Change in Subcategory for a Shareholder under Public Category:

We confirm that the details provided in the Shareholding Pattern for the quarter ended March 31, 2025 are correct. The discrepancy in classification observed in the September 30, 2024 submission occurred due to an inadvertent clerical/human error.

2. Change in Number of Promoters:

While filing the Shareholding Pattern for quarter ended March 31, 2025, the members of promoter and promoters group holding "NIL" shares were not disclosed. However, the same has now been duly corrected and disclosed as required in the revised Shareholding Pattern filed for the Quarter ended March 2025.

3. Mismatch with System Driven Disclosures (SDD):

We submit that the names/entities flagged under SDD were inadvertently missed while filing the Shareholding Pattern for the quarter ended March 31, 2025. The same has been rectified now through filing of the revised shareholding pattern and the details are now correctly disclosed under the relevant table in line with the SEBI circular and prescribed requirements.

The inclusion of the names Ms. Swati Sarupria and Ms. Kashish Bothra in the public category was inadvertent and occurred due to a clerical error. Both individuals have consistently been part of the Promoter Group, and the classification has now been duly corrected.

We regret the clerical oversight and assure you that necessary measures have been taken to ensure accuracy in future filings.
